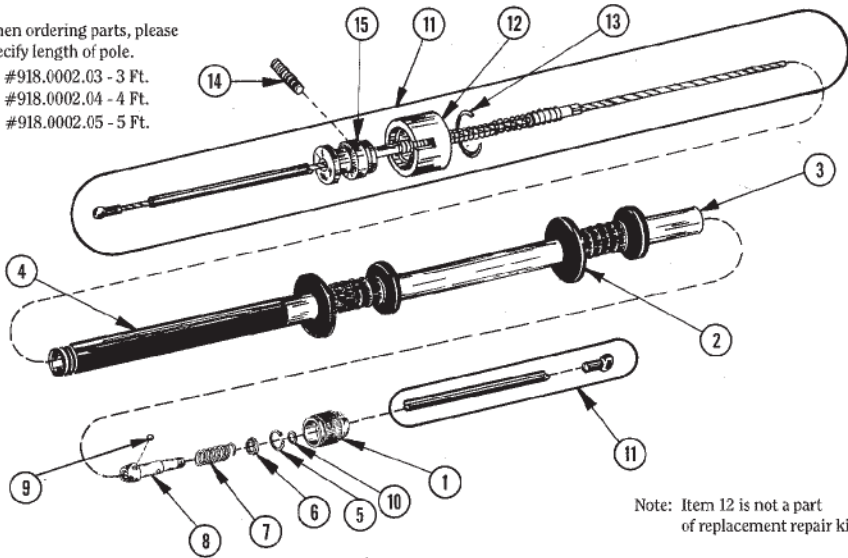

## CABLE REPLACEMENT KIT:

### DISSAMBLY:

NOTE: If you own a current model Fetch Pole and your cable is worn, you will need to cut off the crimped ball from the end of your cable near release knob before disassembly. Older models do not have a crimped ball on the end of cable. Please remove parts in the following number sequence shown on figure 2.

- 1) Remove large lock ring #13 in back of collar #12. Push back on both ends of ring to remove.
- 2) Pull collar #12 back off over tooth guard #4 to expose the #6-32x $\frac{3}{8}$  set screw #14, and remove set screw from head of piston with allen wrench supplied in bag. Note: not to misplace set screw.
- 3) Screw head of piston, which is connected to cable away from pole. (right hand thread).
- 4) When head of piston is free from tubing, go to handle end of pole with release knob.
- 5) Pull back release knob #1, and turn until hole in tubing #3 lines up with the hole in cage #8.

- 6) Inset ice pick, nail or allen wrench through holes to hold locking device from turning.
- 7) Once aligned, turn release knob #1 counter clockwise. (right hand thread), until free from pole. Then proceed with removing lock washer #10.

---

Note: Please take caution when releasing locking device, this section is spring loaded and when released may spring out of pole.

---

- 8) Start removing locking device with lock ring #5. To remove ring you will need internal snap ring pliers. Insert stems on pliers into holes in ring and squeeze pliers removing ring from pole while taking caution of spring releasing.
- 9) Proceed with removing step washer #6, Spring #7, cage #8, and ball bearings #9 from cage. Caution: When removing cage take note that ball bearings may fall out.

## TO INSTALL NEW CABLE KIT

### ASSEMBLY:

Note: Please install parts in following number sequence.

- 1) Re-install new cable kit with crimped ball #11 through pole #3, add collar #12, and large ring #13 as shown in figure 2.
- 2) Re-screw head piston on to pole, and insert set screw #14 back into head piston (Note: make sure hole in pole lines up with hole in head piston). Place cable with crimped ball into groove or slot of collar #12 by making a large loop. Pull collar #12 over head Piston and snap large ring #13 underneath collar #12 around Fetch Pole snare securing noose end of pole.
- 3) Re-install locking device first by installing ball bearings #9 into cage #8. Drop cage with ball bearings down into pole so that screw end of cage faces up. Proceed by loading the following parts in sequence, spring #7, step washer #6, with edge of washer fitting inside of spring, cage lock ring #5 (Note: This is where pliers are needed in order to compress spring enough to fit lock ring within pole locking previous section in place), split lock washer #10, release knob #1 (Note: Align holes of pole and cage while inserting ice pick, nail or allen wrench through holes to hold locking device while you turn release knob and tighten.) Place 5 inch plastic tubing on handle end of cable. Crimp ball on the end of cable #11 to protect user from free wire abrasion.



## FETCH POLE WARRANTY
